6) Cycling UK shall continue to adopt the Nolan Principles ("The Seven Principles of Public Life", published 31 September 1995) and other guidance and best practice for the charity sector in operation of its governance framework. The Nolan Principles includes Selflessness, Integrity, Objectivity, Accountability, Openness, Honesty, and Leadership.

Update on progress against 2021 resolutions

2021 Resolutions

Motion 4 - That the membership fee set pursuant to Article 11 of the Articles of Association shall increase as follows: Household rate from £75 to £78; the Concession rate from £30.50 to £33; the Student/Junior rate from £24 to £33. The Individual rate shall remain unchanged.

Motion 6 - Arrange to be carried out a survey of the general cycling public and specifically non-Cycling UK members and use the insight gained from the survey to strengthen Cycling UK's approach to the market for membership of a National-Cycling-Organisation.

Motion 7 - Cycling UK shall: a) Update its policies on cycle-rail integration – including (but not limited to) the provision of cycle spaces on trains – to reflect the proposals in the Government's Rail White Paper and the cycle-rail commitments in its 'Gear Change' vision document; and

b) Continue to work with the European Cyclists' Federation on issues relating to cycle carriage on cross-channel train services, including the possibility of new night train services.
