# WINNING JOURNEYS

Young Cycling UK award winners pointed the way to a bright future at our Annual Members' Get Together in October. **Tony Upfold** reports

OUNG CYCLISTS Tom Hibbs, Charles Stevens and Will Hsu took centre stage at Cycling UK's Annual Members' Get Together in Manchester.

Tom, Charles and Will had taken very different cycling journeys, but they had one thing in common on 8

October – they were all winners of our top annual award. They were presented with the Arthur Moss Medallion as our Volunteers of the Year, having also been named joint winners of our Young Achiever of the Year accolade.

Tom (21) was homeless little more than a year ago but has turned his life around since being introduced to Ceracycloan, a bike restoration and education centre in Stockport which is affiliated to Cycling UK and involved in our Big Bike Revival project. School friends Charles and Will, who have both now started at university,

pedalled 10,000km from Beijing to Tehran over 114 days this summer, raising more than £30,000 for a children's charity. Charles (19) and Will, who was 18 at the time of the ride, have submitted a claim to Guinness World Records to be recognised as the youngest people ever to cycle the Silk Road.

The achievements of Tom, Charles and Will were among many inspirational stories as the conference floor of the Holiday Inn near Manchester Piccadilly station was taken over for a celebration of all things cycling. About 100 Cycling UK members attended the Annual Get Together.

They were joined by four special guests: Isla Rowntree, founder of children's bike specialists Islabikes and a champion cyclocross and cross-country MTB racer; Julian Sayarer, who broke the world record for a circumnavigation of the globe by bicycle in 2009; Caroline Russell, transport campaigner, London Assembly Member and Green Party Councillor for Highbury East ward in Islington; and Stephen Fabes, a London doctor who spent six years pedalling 53,568 miles across 75 different countries.

#### **CYCLING WORKSHOPS**

Cycling UK Chief Executive Paul Tuohy welcomed everyone to the Get Together and highlighted the work carried out by Cycling UK over the past year.

He then hosted a Q&A session involving Stephen, Julian, Caroline and Isla, with questions both from the audience and from members via email. Topics included equipment for endurance rides, how to encourage more women to cycle, and making streets safer.

Members then split into three workshop groups to listen to presentations and get involved in discussions about the Space for Cycling campaign, the Big Bike Revival, and Member Groups promotion. Stella Shackel (Merseyside Cycling Campaign) and Eric Booth (Bristol Cycling Campaign) spoke about Space for Cycling, while helping showcase the Big Bike Revival was Eve Holt, project co-ordinator for Whalley Range on Wheels (one of our award winners). Colin Waters, secretary of Fleet Cycling, shared his experiences and tips about using social media in the Member Groups workshop.

After lunch, it was awards time – starting with the winners of the Tourist Competition, which resulted in a clean sweep for Chester & North Wales CTC.

# HANG BACK? HANG ON...

Government video blames cyclists for bad driving by lorry drivers, but the London Mayor is pushing for safer lorries in the capital. **Duncan Dollimore** reports

**ORRY SAFETY** was in the spotlight again this autumn. In the last week of September, there were conflicting messages for cyclists. Monday's news was full of woe with the launch of the Government's new cycle safety THINK campaign, featuring a now infamous 'Hang Back' video, which implied that it was always the cyclist's fault if they found themselves on the inside of lorry.

On Wednesday of that week, Cycling UK wrote to Andrew Jones, the Minister responsible for the campaign, explaining why 'Hang Back' was half-baked and politely inviting him to withdraw the victim-blaming campaign and re-think THINK. He didn't.

There was a tacit acknowledgement that the video showed the lorry driver and not

the cyclist performing an unsafe manoeuvre: THINK explained that cyclists needed to be aware that HGV drivers might make fatal errors. But it's a strange road safety message to ignore the lorry driver's responsibility and tell the cyclists to expect and avoid careless drivers.

Fortunately, Friday's news was more loving and giving: London Mayor Sadiq Khan picked an opportune moment to announce his plans to implement a five-star safety rating system for lorries in the capital. The standard is based on the level of vision the driver has from the cab. The most dangerous lorries, where the driver can't directly see pedestrians in front of the cab or cyclists on their nearside, get fewer stars and will be banned from London's streets by 2020. Only the safest lorries will be allowed by 2025, and from next year Transport for London (TfL) and the Borough Councils will require safer lorry standards in all their contracts.

Earlier this year, Cycling UK responded to a TfL consultation on safer lorries, setting out a suggested 'road map' towards the wider uptake of safer lorries with better vision standards, using council procurement powers to promote this. The Mayor's new plan reflects our recommendations.



On 11 October, Cycling UK's Cyclists' Defence Fund was in the Old Bailey, as our private prosecution of Gail Purcell for causing the death of cyclist Michael Mason by careless driving went to its second hearing. Ms Purcell pleaded not guilty to the charge and the case will now go to trial on 3 April. Thanks to over 1,700 members and supporters, we've raised close to £66k, but given the case is listed for a sixday trial, we still need to raise more funds.
