

A WAY AHEAD?

e're a step closer to the creation of a multi-user route for England's newest National Trail, Wainwright's Coast to Coast route, thanks to your donations to the Cyclists' Defence Fund. The Department for Environment. Food and Rural Affairs (Defra) and Natural **England agreed** to further

discussions with Cycling UK Our route suggestions and the British **Horse Society** (BHS) after the two charities threatened legal action over the lack of consideration of a multiuse route

The Wainwright route from St Bees to Robin Hood's Bay has been a popular walking trail for many years and is now to be dedicated as a National Trail. However, Natural England has a legal duty when creating new National Trails to consider how they could be made multi-use. They failed to do this and ignored recommendations from a report by the Yorkshire Dales National Park Authority, which highlighted the wider benefits that a route for cyclists and horse riders could bring. Natural England has now agreed to make this report public and consider the recommendations.

Cycling UK and BHS are proposing a 'braided' route, which follows existing bridleway sections of the Coast to Coast route and then diverts onto parallel trails for other parts. This would not alter the walking route, just create further opportunities for people to enjoy the amazing landscapes in different ways.

Moving forwards, we'll be working with partners along the trail to refine and develop a proposed riders' route, so that it can become an official alternative route for the National Trail, as well as looking at ways to promote responsible access. cyclinguk.org/

CRIMINALS ON DARTMOOR

Veer off the bridleways or byways in Dartmoor and you could be prosecuted for a criminal offence. There are miles of surfaced tracks and old tramways used by rangers and their 4×4s, which it is currently illegal to cycle along. The National Park has the opportunity to update its current



bylaws after 25 years this year. Cycling UK hopes it will listen and remove the unnecessary restrictions for people wishing to enjoy Dartmoor while cycling. cyclinguk.org/ offroadcampaigns
