


## Leicestershire and Rutland Cyclists' Touring Club in conjunction with Charnwood Cyclists' Touring Club





1. This event is not a race or trial of speed. You are expected to follow the rules of the road and show consideration to other users. The route is on public roads and tracks, and is not way-marked or marshalled. You should follow the route sheet as supplied, in conjunction with your own maps, and should only deviate if the route is obstructed. You are responsible for your own safety and conduct. 2. Public roads and rights of way will not be closed for the event and therefore entrants must be aware of other users; ride safely, and follow the Highway Code. You should take in to account the variety of riding styles and abilities, and the likelihood that you will catch up with groups of cyclists along the way. Take care not to reduce your standard of cycling when consulting route sheets, maps, etc., especially when negotiating major roads.

3. If you are unable to complete the ride and abandon, without returning to the finish, **please inform** the organiser - TEL. NO ON ROUTE SHEET !! Please note names of others who abandon to inform the organiser at finish. The control closes at 15.00.
