Secretary's report

AGM 22/23 Secretary Report

I am very pleased to be able to report on a normal year. Most of our cycling activities have become reestablished; each week we arrange 4 On Road rides and 2 Off Road to the cafes and pubs around Reading. We also held 11 Audax events and arranged 8 weekends away to explore further afield.

I would like to particularly thank our Runs Secretary, Simon Bird, who is stepping down after many years in the role. His input will be much missed by myself and other members of the Committee.

52 new Members joined the club over the last 12 months. We now have over 900 members in the Reading postcode areas. It would be great to see some more new faces on our rides. New riders are always welcome, and we never leave anyone behind!

Our Cycling UK Reading Facebook Group continues to grow and has 580 followers, up from 398 a year ago. Please feel free to post there on any cycling related topic.

We also have developed our Strava page which now includes details of our reoccurring rides. 162 cyclists are on there and it's a good way to see where our members are riding.

So here's to some great cycling in 23/24; if the summer is anything like last year we are in for a treat.

Treasurer's report

Cycling UK Reading - Financial Report for 12 months ended 31 March 2023

Overview

The Accounts show a net operating surplus of £6.60 (see Ref G of the Income & Expenditure statement). Accumulated balances amounted to £2,342.47 (see Balance Sheet), after allowing for Debtors and Creditors at the year end.

Matters of interest

Cycling Promotion

The Committee decided against participating in the Reading Cycling Festival of 2022 which meant that the £100 identified for that was not spent. This enabled the Club to break-even rather than generating a loss, which would otherwise have been the case.

Dinton Audax

This was the first year the event had been run since the Covid-19 restrictions and, like many other AUK events, the number of riders was below that previously experienced. Nevertheless, the event generated a surplus of £63. The Club added a further £37 to make a donation of £100 to the Thames Valley Air Ambulance.

Review of accounting for Audax events

In order to comply with the National Office requirements relating to the transparency of financial transactions carried out in the name of Cycling UK the Committee has reviewed the arrangements determined locally, some years ago, and has made some essential changes.

For events run under the name of Cycling UK the following arrangements are to apply with immediate effect:

"Members wishing to run a cycling event under the name of CUKR must first inform the Committee Secretary and Treasurer of his / her intention and identify the name(s) of any charity(s) that the organiser would like to support from any surplus. The Committee will check that the proposed charity(s) meets CUK acceptance criteria and reach an agreement with the Organiser on where any surplus is to be paid. After the event the organiser must present a detailed account of income and expenditure for review / audit by the Club Treasurer and pay any surplus to the club accounts. The Treasurer will make any agreed charitable donation(s) to the agreed charity(s)."

If a member wishes to organise an event that does not comply with the above procedure, then such an event can be organised, but it must not be run under the name of CUK, and CUK Reading will carry no responsibility for the event. The name of CUK Reading must not be linked to any promotional material or social media relating to the event.

Use of the national contribution from subscriptions of £200

We are required to inform the National Office of how our share of the national contribution from subscriptions has been utilised. Details are as follows:

A one-off Audax was organised by Edwin Raj in Phil Rassell's memory in June 2022. Two routes traversing through North Wessex Downs and Chilterns (50 and 100km), aptly named as Pint for Phil, with a pit stop at an appropriate place.

Rides secretary report

Before the establishment of our web site this club used printed rides lists to communicate with members the rides for the forthcoming season.

The onus was on the Rides secretary was to assemble as many rides for the forthcoming three months as possible before the publication date. To make this job easier a number of rides coordinators was established to cover the wide variety of different rides this club offers. So we have the off-road and on-road co-ordinators, currently provided by Ian Doyle (for many years) and Edwin Raj. Less well known are the roles of Lesley Adams who co-ordinates the Wednesday day rides, Rob Butler who arranges the Tuesday make-your-own way rides and Jeanette Jeans who co-ordinates the Wednesday evening rides (soon to be taken over by Alex Watson). My heartfelt thanks to these co-ordinators for their efforts.

On the on-road side we have had a sharp drop off in the number of rides offered on Sundays. By way of re-assurance the off-road is healthy. I'm not absolutely sure why this is but since the end of the Covid-19 pandemic there has been very little response to my three-monthly appeal for rides on the on-road side. I recognise that a number of long-serving ride leaders have done their time and moved on from offering Sunday rides but we are in real danger of losing the well-established Sunday ride slot for on-road rides. What's to be done?

Having served on the committee for just over 10 years as Events Secretary, On-road co-ordinator and now Rides Secretary I've done I think all I can in trying to keep the ship afloat. However, I've run out of ideas. I will keep leading rides and supporting the club where I can but it's now over to the committee to keep the hand on the tiller.

My recommendation to the committee is to consider abolishing the role of Rides Secretary and to give publishing rights to the ride co-ordinators (or even to ride leaders themselves) so that rides can be added by a wider spectrum of people. We are no longer required to package rides of three months for print purposes and it is now largely the practice now for on-road Sunday rides to be added as and when.

Finally, a criticism for Cycling UK. Where is the common IT platform to support member groups so they don't have to run their own websites? To keep our rides leaders covered by Organisers Liability insurance we as a club are obliged to do two things; publish a rides list and register ride leaders. I'd like to see Cycling UK provide this platform. To be fair parts do exist but they are woeful. By comparison British Cycling make it far easier to manage a club. I will attempt to raise this as an agenda item at the Cycling UK AGM this year.

Publicity Office report

Campaigns Officer report

Campaigns Report April 2022 - 2023

I have held the post of CUKR Campaigns officer for nearly 3 years which combines many of the local networking and PR activities I carried out jointly with Reading Cycle Campaign together with CUK HQ larger Campaign programs (such as Big Bike Revival / Space for Cycling / Highway Code changes etc). This role also includes external liaison with Reading Borough Council (RBC) and other transport related bodies (DfT / Sustrans etc); Quarterly Cycle & Transport Forum; communicating key topics back with CUKR committee / share consultation information with members Representing CUKR at Reading Cycle Campaign meetings, co-ordinate with local Environment and other similarly supportive groups and facilitating member attendance at appropriate events.

The primary aim is to ensure a voice for CUKR representing "every day" / commuting cyclists at as many outlets as possible and lobbying for increased share of RBC transport and environmental funding to be spent on suitable cycling facilities. It also enables the Publicity Officer to focus energy on direct publicity and marketing – including recruitment of new members primarily to join rides.

There have been several local transport/ green spaces consultations in the last 12 months and members have been encouraged to input views — either individually or in support of the Committee / Reading Cycle Campaign responses. The latest Tranche 2 Active Travel funding consultation resulted in minor modifications to the plans to implement a 2-way cycle lane on Shinfield Road, and some changes to layout on Redlands Road / Sidmouth Street rather than many other much higher priority cycle infrastructure improvements where alternative plans are being assessed.

Most RBC meetings are now quarterly at the Council offices with the addition of the Cleaner Air, Safter Streets (CAST) forum which brings in a wider participation schools and community groups which is a benefit for gaining Council airtime and investment to support cycling and walking initiatives; as well as the Cycle / Transport Forum. Reading Cycle Campaign have held several "inclusive" rides around Reading's best — and worst - cycling infrastructure to highlight the good, bad and ugly of transport planning — aim to link participants with CUKR for the more "leisurely" side of cycling.

Cycling UK Central HQ has continued to deliver its annual schedule of events; including further rounds of the **Big Bike Revival Campaign** (specifically focussed on encouraging new or returning riders through free bike repair workshops; beginner lessons and leisure rides / plus Dr Bike sessions at , Women's Festival of Cycling and **Bike Week.** I have continued to support these through partnerships with Reading Bicycle Kitchen and Avanti Cycling – gaining funding for the Reading area and encouraging a source of potential new members for CUKR.

This year **Bike Week** runs from **5-11 June 2023 will mark the 100th annual Bike Week**, marking a century of celebrating everyday cycling for everyone. The aim is for local clubs to put on additional rides during the week - specifically aimed at new members / more leisurely – so if you'd like to volunteer to run a ride please do! We will put on additional publicity and register all events on the central site to try and help gain new riders/ members

The annual Reading Cycle Festival is on Sunday 10th September 2023 in Christchurch meadow. I very much hope CUKR will be able to take part with our own stand to promote the club locally. More volunteers are needed to help man a stand on the day and/ or lead leisure rides (on and off road) to end up at the event. The Festival Organising Committee are also looking for additional volunteers to

help with the overall festival logistics/ marshalling on the day etc. please contact me on campaigns@cyclingukreading.org.uk to express interest or find out more.



RBC Active Travel Funding

A Council supported plan to create a "Cycle Hub" in the town centre – effectively secure Bike parking with information / tools etc (old Primark Building) has been significantly delayed due to issues with the lease/ landlord etc. However, we are hopeful this will be open later in Spring this year. I have requested opportunity to have CUKR publicity material on display when this opens (and ideally visible branding on walls/ banners etc). Joe Edwards (Chair of Reading Cycle Campaign) and I are involved along with various other interested parties including Sustrans/ the Bicycle Kitchen & Ethical Reading.

RBC are funding programme of Adult cycle training from beginner to road commuting skills, being run by Avanti Cycling and Bike maintenance workshops; being run by Reading Bicycle Kitchen. https://avanticycling.co.uk/well-give-you-the-confidence-to-ride/

Both these activities are potential good sources of new CUKR members. I've put lots of people in touch with the CUKR Club website & FB groups and have has some new riders (and two members!)

Still need the offer of leisurely / sub 20-mile rides to encourage more newcomers at this level as I'm frequently asked for the next step after someone has completed several road based confidence sessions.

You may also be interested in supporting / following **Kidical Mass** monthly events which have gone from strength to strength during 2022/23. Kidical Mass rides are a worldwide initiative, where

children of all ages take to the streets of towns and cities, on bikes, adapted cycles, wheelchairs, balance-bikes etc, under safe and properly marshalled conditions. The aim is to encourage others to consider making short journeys by bike, or other active travel choice, rather than taking a car. To find out more follow them on FACEBOOK.
